

1. Introduction

Welcome to e-farmer (“Company”, “we”, “our”, “us”)!

These Terms of Service (“Terms”, “Terms of Service”) govern your use of our website located at “e-farmer.co.in” (together or individually “Service”) operated by e-farmer.

Our Privacy Policy also governs your use of our Service and explains how we collect, safeguard and disclose information that results from your use of our web pages.

Your agreement with us includes these Terms and our Privacy Policy (“Agreements”). You acknowledge that you have read and understood Agreements, and agree to be bound of them.

- 4.4 The bid winning buyer has to pay within one hour or else the next highest bidder is selected as winner.

5. Refunds

We issue refunds for Contracts within 10 days of the original purchase of the Contract. However there will not be any refund if the farmer has already dispatched the purchased product.

6. Content

Content found on or through this Service are the property of e-farmer or used with permission.
